### Editor's Top 5 Recommended Reading and Latest Articles sections

A recent article by Rosendale et al.,  $^1$  that studied hospital admission and readmission among homeless patients with neurologic disease using the California State Inpatient Database found the most common neurologic reasons for admission among homeless patients are seizure and traumatic brain injury. Homelessness was associated with an increased 30-day readmission rate (odds ratio 1.5, 95% confidence interval 1.4–1.6, p < 0.001).

Another new addition is an article by Weber et al.<sup>2</sup> on the topic of educational compensation in academic neurology departments. Using survey answers by chairs of neurology, the authors found that 36% of departments offered direct compensation for teaching efforts and 36% did not. The position with the most salary support was residency program directors at 36.5% full-time equivalent.
